**Part Two - CONTRACT FORMATION SECTION**

1. Allocation of the Port Services will always be subject to availability and suitability for the use intended by the Applicant or the Port User. GeelongPort will determine availability, suitability and allocation of the Port Services in its absolute discretion.
2. If the Applicant or the Port User (**User**) is allocated or otherwise given access to the Port Services by GeelongPort then the User will be automatically bound by a contract with GeelongPort Pty Ltd that contains the terms and conditions set out in GeelongPort's Port Standards and Procedures (incorporating and GeelongPort's Rates and Charges and the VRCA's Handbook) (**Terms and Conditions**). Copies of these important Terms and Conditions can be obtained:
  - (a) by submitting a request by fax on (03) 5272 1560 marked for the attention of the Port Operations Manager; or
  - (b) by calling in person at GeelongPort's office; or
  - (c) from the port information posted on the website [www.geelongport.com.au](http://www.geelongport.com.au) or any other website advised by GeelongPort from time to time,however, copies of the VRCA's Handbook (*Victorian Regional Channels Authority Port Waters of Geelong's Operating Handbook 2005* as updated or amended from time to time) are only available from the Victorian Regional Channels Authority or on the VRCA's website [www.regionalchannels.vic.gov.au](http://www.regionalchannels.vic.gov.au).
3. The User is responsible for checking the Terms and Conditions from time to time to ascertain whether or not additions or variations have been made.
4. Nothing will create any tenancy, estate or proprietary interest of any kind in favour of the User.
5. Without limiting anything in the Terms and Conditions, the Applicant and the Port User shall be jointly and severally liable for the payment of all charges imposed by GeelongPort in relation to the hire or use of any Port Services.
6. Except to the extent that any rights or warranties cannot be excluded or limited as a matter of law, the liability of GeelongPort to the Applicant and the Port User for anything arising out of the use of the Port Services in the Port of Geelong shall be strictly limited to either of the following remedies as elected by GeelongPort:
  - (a) the re-supply of an equivalent service; or
  - (b) the payment of the costs necessary to have the Port Services supplied again.
7. The Applicant:
  - (a) if it is submitting this Application on behalf of a Port User, warrants that it has the Port User's authority to submit this Application and has the Port User's authority to bind the Port User to the Terms and Conditions;
  - (b) undertakes to pay all of the fees and charges incurred in connection with the hire or use of the Port Services that are allocated to the User by GeelongPort following the submission of this Application;
  - (c) acknowledges that by submitting this Application electronically or by any other means (with or without any signature) it will be deemed to have executed this Application and accepted the Terms and Conditions; and
  - (d) undertakes to advise any Port User for whom it is acting of the Terms and Conditions.
